### US EPA Emission Control Warranty Statement Your Warranty Rights and Obligations

The U.S. Environmental Protection Agency (EPA) and Wisconsin Motors, LLC are pleased to explain the emission control system warranty on your new non-road large spark ignition engine. New non-road large spark ignition engines must be designed, built and equipped to meet the U.S. EPA's stringent anti-smog standards. Wisconsin Motors, LLC must warrant the emission control system on your non-road large spark ignition engine for the periods of time listed below provided there has been no abuse, neglect, improper maintenance, or unapproved modification of your non-road large spark ignition engine.

Your emission control system may include parts such as the air-induction system, the ignition system, the catalytic converter and the crankcase ventilation system. Also included may be hoses, connectors and other emission-related assemblies.

Where a warrantable condition exists, Wisconsin Motors, LLC will repair your non-road large spark ignition engine at no cost to you including diagnosis, parts and labor.

#### **Manufacturer's Warranty Coverage**

2008 and later emissions critical components of your non-road large spark ignition are warranted for 1500 hours or 3 years, whichever comes first (refer to Group 1 below). Certain emissions critical components of your non-road large spark ignition engine are warranted for 1500 hours or 5 years, whichever comes first (refer to Group 2 below). If any emission-related part on your engine is defective, the part will be repaired or replaced by Wisconsin Motors, LLC.

#### **Owner Warranty Responsibilities**

As the owner of a non-road large spark ignition engine, you are responsible for the performance of the required maintenance listed in your owner's manual. Wisconsin Motors, LLC recommends that you retain all receipts covering maintenance on your non-road large spark ignition engine, however Wisconsin Motors, LLC cannot deny warranty solely for the lack of receipts or for your failure to ensure the performance of all scheduled maintenance.

As the owner of a non-road large spark ignition engine, you should be aware that Wisconsin Motors, LLC may deny you warranty coverage if your non-road large spark ignition engine or a part has failed due to abuse, neglect, improper maintenance or unapproved modifications.

You are responsible for presenting your non-road large spark ignition engine to a Wisconsin Motors, LLC distribution center as soon as a problem exists. The warranty repairs should be completed in a reasonable amount of time, not to exceed 30 days.
